WaterSafe consent form

WaterSafe is an online register and search facility of approved plumbing contractors working in the UK. Its purpose is to help customers find a competent and qualified plumber. Qualified plumbers help to keep water supplies safe by ensuring plumbing systems inside customers properties are installed correctly and comply with the Water Supply (Water Fittings) Regulations 1999 and Byelaws.

The WaterSafe scheme brings together the seven existing Approved Contractors' Schemes under one umbrella brand. The Scheme recognises qualified professional plumbers who are employed by a business, which is a member of one or more of the seven Approved Contractors' Schemes. Watermark is one of the seven Approved Contractors' Schemes operating under WaterSafe.

The online directory is free to use for customers and WaterSafe membership is also free for eligible existing Approved Contractors' Scheme members.

Appendix 1

Code of Conduct

- No member will give misleading information to its customers.
- All members will give a competitive price to its customers.
- No member will bring the name of the WaterMark scheme or of Severn Trent into disrepute.
- All 3rd party complaints or claims against a member shall be investigated and dealt with by the member concerned.
- All members shall inform WaterMark of any change of circumstance with regards to their membership details.
- It is the member's responsibility to ensure that all work undertaken is in accordance with the Water Supply (Water Fittings) Regulations 1999.
- It is the member's responsibility to ensure where necessary that the water undertaker is notified before work is undertaken in accordance with Regulation 5.
- In the case of a fitting for which notice is required under Regulation 5, the member shall send a copy of the self certificate to the WaterMark team.
- Where a water fitting is installed, altered, connected or disconnected by a WaterMark member, the member shall upon completion of the work furnish a signed certificate stating that the water fitting complies with the requirements of the Regulations to the person(s) who commissioned the work.
- All members of the scheme are responsible for ensuring each member of staff is suitably qualified and competent in their understanding and knowledge regarding the application of the Water Supply (Water Fittings) Regulations 1999.
- For every five plumbers there must be at least one plumber who has the required qualifications (See section 2) to supervise and sign off all installation work covered by the WaterMark self certification form.
- The qualified contractor must supervise all installation work that is covered by the certificates. The self certification must only be signed by the approved member of the scheme.
- RPZ valve accredited testers will furnish an annual copy of their customer calibration certificates to the WaterMark team. The test certificates must be submitted to Severn Trent within 10 days of the test date.
- A copy of your public liability insurance certificate must be submitted to the WaterMark team annually.
- All members are responsible to uphold the WaterMark code of conduct.

Appendix 2

Terms & Conditions

1. WaterMark Approved Contractor Scheme (hereinafter referred to as the scheme)

The Water Supply (Water Fittings) Regulations 1999 (hereinafter referred to as the Regulations) set requirements for the design, installation and maintenance of water fittings and plumbing systems.

The Department of Environment, Food and Rural Affairs (Defra) allows organisation's such as Severn Trent to run an approval scheme, which enables approved plumbers/contractors to self-certificate their own work.

This removes the need for a separate inspection to be carried out by the water undertaker to ensure compliance of the Regulations is met. The water undertaker has a legal duty to enforce the Regulations within their area of supply.

2. Membership Requirements

To become a WaterMark approved contractor you must be fully qualified and demonstrate competency of 'Working on the tools'. A list of the qualifications required for membership is set out in the formal application pack.

Applicants will be required to hold one of the following Water Regulations qualifications BPEC, WRAS LOGIC, NVQ or City & Guilds in the Water Supply (Water Fittings) Regulations 1999.

3. Standard of Work

All work(s) undertaken must comply fully with the requirements of the Regulations.

To ensure that compliance with the Regulations is maintained, a proportion of completed jobs may be subject to random audit.

Where a member undertakes the installation and repair of gas installations, it is the responsibility of the member to ensure the work(s) undertaken is in accordance with the relevant Gas Safety Regulations. The member must also hold the appropriate (Gas Safe) qualifications.

4. Self Certification

Approved members are permitted to certificate work(s) for up to five contractors working under his or her 'Responsibility'.

It is a requirement under the terms and conditions of the scheme that sub contractor(s) operating on behalf of an approved member still has the 'Responsibility' to ensure that any work(s) undertaken is inspected and self certified accordingly to ensure compliance of the Regulations are met.

The approved member shall keep a record of all certificates issued for not less than two years as a requirement under the terms and conditions of the scheme. The member must also furnish the WaterMark Team with certificate copies on a quarterly basis.

A self certification form must be completed for all work carried out on new development sites. A copy of the form must be submitted to Severn Trent prior to any connections being made.

The WaterMark Team will keep copies of all jobs submitted.

5. Cost of Membership

There is a one-off non-refundable joining fee of £100 per application, plus an annual membership fee of £50 per company per calendar year will then be charged.

6. Administration

The scheme is administered on a daily basis by the Water Fittings Regulations Team. Our offices are open, Monday to Friday from 9:00am until 4:00pm.

7. Auditing of the Scheme

All new members wishing to join the scheme will be audited by the Water Fittings Regulations team prior to membership status being granted.

The Water Fittings Regulations team will arrange to undertake an audit with the applicant at a time/date that is convenient with both parties. Audits will only be undertaken within the Severn Trent area of supply.

WaterMark may carry out annual audits (or where applicable) on members to ensure that any work(s) undertaken complies with the Regulations.

WaterMark will contact the customer and/or member informing them of our intention to carry out an audit inspection. The member need not attend the inspection unless specifically requested to do so.

Any contravention of the Regulation's found as part of the audit will be discussed with all parties.

Failure by the member to rectify (at their own expense) any contravention(s) found during, or subsequent to the inspection, will make them liable for removal from the scheme and possible legal action by Severn Trent.

8. Insurance

Members/applicants MUST have public liability insurance cover to the minimum value of £2.000.000 (Million).

9. Disputes

All 3rd party complaints or claims against a member shall be investigated and dealt with by the member concerned.

Any dispute between the member and Severn Trent shall be referred to the Water Fittings Regulations Manager. It shall be the role of the WaterMark team to arbitrate in the event of a dispute, after allowing both sides to present their case.

10. Appeal

In the event of a dispute resulting in the termination of membership or Regulations infringements being upheld, the Water Fittings Regulations Manager will determine a decision in any such appeal. Any such decision will be final and non-negotiable with all parties being bound by the decision.

11. Termination (Company)

If a member is found to be carrying out work which is not in accordance with the Regulations, or fails to comply with any of the foregoing requirements, WaterMark reserve the right to terminate your membership and remove the company from the approved list of contractors.

Any company that has been removed from the approved list shall remove all membership reference from his/her advertising material and stationery with immediate effect. Possible legal action may be taken by Severn Trent if an offence has been committed under the Regulations and is deemed in the interest of the general public.

12. Termination of the Scheme By Severn Trent

Severn Trent reserves the right to terminate the scheme at any time for whatever reason without prior notification.

13. Terms of Membership

Severn Trent reserves the right to alter and/or amend the terms and conditions of membership without prior notice.
